CHAPTER 1 INTRODUCTION

1.1 GENERAL DESCRIPTION

The VT62 video display terminal is a 24-line, 80-character display terminal that serves as an input/output (I/O) device to a host processor. This terminal transmits and receives data at speeds up to 9600 baud. The terminal features a main keyboard which uses a standard typewriter layout. This keyboard supplies uppercase and lowercase alphabetic characters as well as numeric, symbol, and control characters to a host. The video display of the terminal uses a 7×8 dot matrix to form the displayable characters.

1.1.1 VT62 System Description

The VT62 (Figure 1-1) is a buffered CRT terminal designed for data entry and retrieval applications.

Like the VT61 and VT52, it is an uppercase and lowercase ASCII video terminal whose display holds 24 lines of 80 characters.

The VT62 is unique, however, because it is an application terminal for use in the commercial markets. It is specifically designed for commercial data capture and retrieval applications. It is made to be operated by personnel not specially trained in the use of "computers." The host computer defines the areas on the screen which the operator is allowed to enter, to fill in, or to select. The terminal provides most of the real-time detailed checking of operator responses, but the ability to extend some of the more complicated checking, such as file searches, to the host computer is provided. Operator errors are signaled by an audible tone, an error light, and a short, but descriptive message of what went wrong. Because the host computer loads the message array, it is not necessary to restrict the messages to the English language.

The VT62 uses a standard typewriter keyboard (Figure 1-2) except that the shift lock key is labeled CAPS LOCK, and affects only the alphabetic keys. Operator-oriented features include an adjustable clicking sound which provides feedback as the operator strikes the keys and multiple key rollover to eliminate scrambling of characters, even if several keys are hit simultaneously. The VT62 also has a numeric/special function auxiliary keypad (Figure 1-3).

The 10 numeric keys and the "." key on the 19-key auxiliary pad serve an additional function as program function keys. The program function is indicated by a label on the front of the key cap and is obtained by striking the key while the SHIFT key is pressed.

The terminal can be placed in a special mode, selectable by the host software, in which the PRO-GRAM FUNCTION keys operate without the use of the shift key. In this case, the program foregoes the normal function of the numeric keypad.

Note that the numeric keypad is functionally self-contained. If all replies in the form are numeric, then the entire form can be entered and sent with one hand which need never move from the pad.

The VT62 provides eight light-emitting diodes (LEDs) (located to the right of the 19-key auxiliary pad) that indicate to the operator when a particular operating mode or condition of the terminal is in effect.

1.2 FEATURES

The VT62 contains many special features to enable foolproof operation by relatively unsophisticated users. It also provides reliable, cost-effective communication connections to DIGITAL computer systems for both local and distributed terminal networks.

Important features of the VT62 are:

- 1. Multipoint DDCMP block-oriented communication
- 2. Half or full duplex and asynchronous or synchronous communication for application flexibility
- 3. Formatted split screen display with protected fields, menu selection, invisible password field, and reverse video
- 4. Local data checking and error notification for many operator errors
- 5. DEC standard typing keyboard augmented by many special functions for operator convenience
- 6. High-level software support.

1.2.1 Control

The operation of the VT62 terminal is under the control of the host computer, and not of the terminal operator. However, many data input, editing, and correction functions are at the disposal of the terminal operator. Software in the host or front end computer controls the format of the terminal's display.

For foolproof, protected operation by unsophisticated terminal users, the terminal has no direct access to the operating system of the host machine: the analyst configuring a system with VT62 terminals can grant to the terminal user only those features needed to get the job done.

1.2.2 Formatted Screen

The visible screen of the VT62 is the same as that of the VT61: 24 lines of 80 characters each. The screen displays both uppercase and lowercase characters. The visible cursor alternates between normal and reverse video at approximately 2 Hz.

The VT62 display is "formatted," that is, it consists of protected fields:

- 1. DISPLAY AREA for operator prompting and information provided in a rigid format described by the software which the operator is unable to alter from the keyboard, and
- 2. FORM AREA for data entry also established by the software with certain syntactic characteristics which are enforced by the terminal.

All text on the screen (except, to some extent, the input fields defined by the host software) is protected from the operator. A program in the host computer defines the fields for operator input by giving tables to the terminal.

1.2.3 Input Fields

The host software's field definitions instruct the system:

- 1. How to display the field
- 2. What checks to perform on the data entered in the field (if any)
- 3. Which format to return the entered data to the application program.

Field definitions supplied by the host software can specify the following attributes:

- 1. Field number
- 2. Screen position (line and column)
- 3. Length
- 4. Character type, for example:
 - a. Numeric
 - b. Numeric with decimal point (.) and sign (-) allowed
 - c. Alphanumeric with no special characters
 - d. Any displayable characters
- 5. Field must be entered
- 6. Field, if entered, must be full length
- 7. Right/left justified
- 8. Field may not be altered by operator.

1.2.4 Automatic Field Checking

Character-type restrictions are enforced by the terminal as the operator is entering the content of the field. For example, the terminal does not allow an operator to enter any other characters than 0 through 9 in the field defined as numeric. Some other examples of how the terminal enforces field definitions are:

The "alteration" restricton is checked when the cursor attempts to enter the field: if the field may not be altered, then the cursor moves to the next field (in the current direction, forward or back).

The "non-empty" and "full" restrictions are checked when the operator attempts to move the cursor out of the field: until certain conditions are met, the operator may not go on to the next field. For example, if a field must be entered, the operator must place something non-blank in the field before continuing.

1.2.5 Error Messages

When an operator error is detected by the terminal, one or two messages appropriate to the field type are displayed for the operator on the bottom line of the screen, and the terminal rings the "bell." The error messages are removed from the error line (the bottom line of the screen) when the operator completes the field correctly.

A table of error messages is maintained by the terminal in an "off-line" mode to give guidance to the operator filling in the form. The error messages are loaded into the terminal by the host computer during the initial definition period. These error messages are maintained by the terminal in an "off-line" mode, that is, without intervention of the host computer during the transaction process.

The bottom line of the screen is reserved for the use of the error messages, if they are present. If no messages are sent to the terminal for off-line cueing, then the bottom line of the screen can be used by the program.

Error messages may be given under the following conditions:

- 1. Field length exceeded
- 2. Non-digit in numeric field
- 3. Illegal character in amount field
- 4. Special character in alpha field
- 5. Field entered less than full length
- 6. Required field not entered
- 7. Attempt to alter protected text.

1.2.6 Program - Controlled Screen Layout

The screen of the VT62 can be divided conceptually into two parts, for the convenience of the operator and the programs. The top portion of the screen is called the DISPLAY AREA, and the bottom the FORM AREA (Figure 1-4).

The dividing line between the two areas is conceptual only: there is no visible indication. The location of the "division" is under program control. A program can choose to devote from 0 to 24 lines of the screen to the display area, leaving the remainder of the screen for the form area.

1.2.6.1 Display Area – The display area is intended for two uses: to supply dynamic information to the operator, and to allow the operator to choose easily from structured menus.

The display area can be cleared, filled, altered, or changed in size under program control. Operators may not alter its contents in any way, but they can move the visible cursor into the area to select an item from a menu displayed there.

1.2.6.2 Display Area Menu Selection – Within the display area of the screen, the operator's cursor moves freely throughout the text presented there.

To choose a menu item (Figure 1-5), the operator merely positions the cursor anywhere within the text of the item, then presses either the ENTER key or one of the PROGRAM FUNCTION keys.

If the operator's cursor is within the display area of the screen when the ENTER key or one of the PROGRAM FUNCTION keys is pressed, then the terminal sends the cursor position to the host as an indication of menu item choice.

1.2.6.3 Dynamic Displays – The display area can also be used to supply the operator with dynamic information of interest, or to provide responses to previous operator input.

The VT62 can receive unsolicited messages from the host machine at any time, without disturbing operator keyboard activity. Thus, the display area can be updated at any time by the host, to provide current reports in static format; or it can be scrolled upward (independent of activity in the form area), to provide running information.

Examples of these uses are:

- 1. A fixed-format display of a stock portfolio, with values computed on most recent market transactions.
- 2. A running stock ticker, giving all market activity, one or several transactions per line, with old transactions scrolling off the screen.

To respond to previous operator input, a program can clear the entire screen, establish the size of the display area needed, and send the reply followed by the next form.

1.2.6.4 Form Area – The form area is used to hold a protected form and fields for operator data entry. Text layout in the form and fields within the form is arbitrary, as determined by the program.

The order of processing of fields is determined by the host software. For example, fields can be defined so that they appear to be ordered in columns, top to bottom, rather than across the screen, left to right.

Within the form area, the operator can move his cursor from field to field, and among the characters within a field. The cursor cannot be placed on protected text inside the form area. The repeating FORWARD FIELD and BACK FIELD keys are provided for rapid access to fields. The repeating cursor keys are provided for rapid positioning within a selected field.

Keyboard text entry is always done in overstrike mode: rekeying is generally faster and more accurate than editing the contents of individual fields. However, special keys are provided to insert or delete characters from any location with a defined field.

1.2.7 System/Terminal Configurations

The VT62 can be connected to a system in multipoint and single-point configurations using a multiplexer (Figure 1-6). Local single-point connections can be accomplished without modems.

In either case, the VT62 acts as a DDCMP multipoint tributary (multidrop slave, circumspect mode), transmitting only when polled by the host or front end computer. In multipoint configurations, therefore, the host computer has complete control over all the terminals connected by multidrop lines – and many terminals can be serviced concurrently. In single-point configurations, the host computer has complete control over the terminal's demands on the system's resources.

All communication between the terminal and the computer is in blocks of data containing both commands and text.

The VT62 may be configured three ways:

- 1. EIA synchronous, up to 4800 baud: for use with a synchronous modem as a stand-alone multidrop terminal.
- 2. EIA asynchronous, up to 9600 baud: for direct radial (single-drop) connection to a host or concentrator, as a high-speed local terminal.
- 3. 20 mA asynchronous, up to 9600 baud: for direct radial (single-drop) connection to a host or concentrator, as a high-speed local terminal (with the optional 20 mA Communications Interface Card).

1.2.8 Power-Up State

When powered up in the ON-LINE mode, the terminal immediately enters Short Self-Test. At the end of the Self-Test (approximately ten seconds), when polled, the terminal sends a DDCMP START or START ACKNOWLEDGE message to the host. The host software can then take action to set up the terminal for the operator. It is possible, in case of temporary loss of power, that the host may have to take special action to continue transactions that were in process.

To the operator, the terminal screen is blank, and the keyboard is locked.

1.2.9 Data Transmission

If the cursor is within the form area of the screen when the ENTER key is pressed, the contents of all fields entered by the user is sent to the host.

Transmission of data from the input fields can be in packed or unpacked format, at the discretion of the software. In packed format, only fields entered or modified by the terminal operator are transmitted, and these fields are null-compressed. In unpacked format, all characters of all fields are transmitted, with no data compression, and no field separators.

1.2.10 Printer Option

On command from the host, the terminal will send information to the printer interface. Three types of printing are possible:

- 1. Dump the display portion of the screen
- 2. Dump one specific line from the screen
- 3. Send text directly to the printer without altering the content of the screen.

No additional formatting is implied. The screen is not cleared or altered.

CHAPTER 2 INSTALLATION

2.1 SITE PLANNING

The design of the VT62 will normally pose few constraints on the selection of a place to install the terminal (Figure 2-1). In most cases, any environment which is suitable to the operator of the terminal will be a satisfactory environment in which to operate the terminal. Extremes of temperature and humidity should be avoided. A summary of the guaranteed operating conditions of the VT62 is found in Chapter 1.

2.2 UNPACKING AND INSPECTION

- 1. Unpack the terminal and place it on the desk or the surface where it will be operated.
- 2. Inspect the terminal for physical damage.
- 3. Make certain that site power meets the requirements of the terminal. Information concerning the electrical requirements of the terminal and the communications interface supplied with the unit is provided by the identification tag located on the rear of the terminal (Figure 2-2). This tag also contains the serial number and the model number of the terminal. Use Table 2-1 to translate the identification tag data into usable information.

All VT62 models come equipped with the parallel interface for the printer (LA180 or equivalent). However, the printer is supplied separately and is not specified by the model number of the VT62.

2.3 INSTALLATION AND SET-UP

Perform the following steps to install the VT62:

CAUTION Make certain that the terminal line cord is not connected to an electrical outlet, and that the power (ON/OFF) switch is in the OFF position (Figure 2-2).

- 1. Place the unit upside down on a bench or table (Figure 2-3).
- 2. Remove the upper cable clamp securing the option cable to the base assembly (two Phillips head screws $8-32 \times .38$) using a Phillips screwdriver.

3. The forward portion of the terminal base (the base front screen) can be removed to gain access to part of the terminal's electronics.

This allows the operator to:

- a. Remove the communications interface card and replace it with another communications option.
- b. Access the Terminal Address Switch and/or the HALF/FULL DUPLEX, PARITY ON/OFF, PARITY EVEN/ODD, 7/8 DATA BIT, and 50/60 Hz switches located inside the unit.
- c. Plug in the cable to the printer.

The base front screen is held down at the rear by five hex-head screws and at the front by a lip in the shell material. By unscrewing the hex-head screws, this section of the base can be lifted out. It is not necessary to remove the entire base.

Use care when removing this section of the base, as the switches and speaker which are attached to the screen will still be connected to the internal electronic by a cable (Figure 2-4).

- 4. Remove the switch panel board connector P1 from J4 on the I/O board (Figure 2-4).
- 5. A 40-pin male Berg connector is visible at the right in Figure 2-4. This is the connector for the general output register (printer). The cable from the LA180 or equivalent printer should be attached to this plug so that the lettering on the cable faces you and can be read.
- 6. There are two 11-pin connector rows in the center of the printed circuit board (Figure 2-5). The communications interface card (20 mA or EIA) is plugged into one or both of these connectors depending on its size. A single-width card that has only one connector on its underside (i.e., the 20 mA card) will plug into the connector closest to the front of the unit (Figure 2-6). The BN61B EIA connector, which provides control as well as data signals, will use both rows of pins (Figures 2-7 and 2-5). Appendix B contains complete communications interface installation instructions.
- 7. The Limited Access Operator Control Switches (Figure 2-8), are also found under the base screen. The switches are shown by a diagram mounted on the portion of the base screen that was removed (Figure 2-3).

Make certain that Limited Access Switch 4 (LAS 4) is in the ON position.

Make certain that LAS 7 is in the OFF position.

NOTE

The VT62 can be set up with Limited Access Control Switch 7 in the ON position. This causes the VT62 to always remain ON-LINE, regardless of the setting of the ON-LINE/OFF-LINE Control Switch.

Set LAS 8 (the 50/60 Hz switch) to match the line frequency (within 1 Hz) to ensure that the video display is easy to read.

At this time Parity (LAS 1), Even/Odd Parity (LAS 2), 7/8 Bits (LAS 3), and Half/Full Duplex (LAS 6) selections should be made.

8. If a terminal address is required, set the Terminal Address Switch at this time (Figure 2-5).

There is an adjustment by which the user can adapt the VT62 to the higher voltage ranges (180-254 V). This switch is found on the power supply module (Figure 2-9) and is clearly marked "115" (for the 90-127 V range) and "230" (for the 180-254 V range). To gain access to the power supply, the rear louver plate must be removed. In addition to the steps covered so far, this will involve removing the screws in the rear louver plate with a 1/4 inch nut driver and removing the louver plate. Reverse these steps before applying power.

9. Replace the switch panel board connector P1 to J4 on the I/O board.

CAUTION

Make certain that P1 is replaced correctly on J4, with the black wire of the cable toward the front of the unit. P1 incorrectly replaced on J4, will damage the I/O board upon power-up, necessitating its replacement.

- 10. Replace the base front screen by reversing Step 3.
- 11. Secure the option cable to the base assembly by reversing Step 2.
- 12. Figure 2-3 shows another cable coming from the unit. This cable will have a Mate-N-Lok connector or an EIA connector, depending on which option you have ordered. Plug this connector into the I/O part of the computer or modem with which you wish to communicate.
- 13. Make certain that the rear louver plate is back in place and then return the VT62 to its operating position.
- 14. Plug the 3-pronged line cord of the unit into an electrical outlet that meets the requirements of the terminal.
- 15. The power (ON/OFF) switch is at the rear of the unit (Figure 2-2). Make sure it is in the upper (ON) position.

NOTE

Run the interface cabling to the host according to the appropriate cable configuration diagram located in Figure 2-10.

2.4 ACCEPTANCE TEST PROCEDURES

2.4.1 VT62 OFF-LINE ACCEPTANCE TESTS

The following paragraphs list the off-line acceptance test procedures.

2.4.1.1 Set-Up Procedure

NOTE

Perform the initial set-up procedure in Paragraph 2.3 before continuing with this procedure.

1. Make certain that the terminal line cord is not connected to an electrical outlet and that the power (ON/OFF) switch is in the OFF position.

- 2. Tip the unit back until it is stable. This is done to gain access to the operator control switches (Figure 2-11).
- 3. Set the ON-LINE/OFF-LINE switch to the OFF-LINE position (Figure 2-12).
- 4. Return the VT62 to its proper operating position.
- 5. Plug the 3-pronged line cord of the unit into an electrical outlet that meets the requirements of the terminal.

2.4.1.2 Self-Test Procedure

- 1. Make certain that the CAPS LOCK key on the main keyboard is not in the pressed position.
- 2. Apply power to the terminal by setting the ON/OFF switch to ON. This switch is located on the rear of the terminal.

NOTE

The terminal enters a self-test mode immediately upon power-up. If the terminal CAPS LOCK key is in the released position, the VT62 enters Long Self-Test mode. The VT62 will remain in this mode until the CAPS LOCK key is pressed.

Press the CAPS LOCK key. 3.

NOTE

When the CAPS LOCK key is pressed, the terminal enters Short Self-Test mode. When the Long Self-Test reaches the bottom of the current screen, it then executes the Short Self-Test one time (approximately ten seconds). At the end of the Short Self-Test, the terminal exits the Short Self-Test mode, the cursor goes to the HOME position (at the top left corner of the display), and the keyboard is enabled.

- 4. Remove power from the terminal by setting the VT62 ON/OFF power switch to OFF.
- 5. With the CAPS LOCK key still in the pressed position, reapply power to the terminal by setting the ON/OFF switch to ON.
- 6. Make certain that the terminal enters Short Self-Test mode and executes the Short Self-Test one time (approximately ten seconds).

2.4.1.3 Flashing Cursor Check – At the end of the Short Self-Test, the terminal cursor will go to the HOME position and the keyboard will be enabled. Verify that the flashing cursor appears at the upper left corner of the screen (the HOME position).

Using the intensity control located on the rear of the terminal (Figure 2-13) adjust the brightness of the cursor to the desired level. For comfortable viewing, set the brightness to the lowest possible level while still maintaining good character definition. High screen intensity causes characters to become fuzzy and prolonged viewing of the bright display is very tiresome.

2.4.1.4 Display All Check – The terminal may display a dot in each character position. This is caused by the DISPLAY ALL switch being in the DISPLAY ALL position.

Move the DISPLAY ALL switch (Figure 2-12) several times between the DISPLAY ALL and normal positions and verify that these dots can be made to appear and disappear. Place the DISPLAY ALL switch in the normal position. (The normal position of the DISPLAY ALL switch is toward the front of the terminal.)

2.4.1.5 CAPS LOCK Check – Note the key labeled CAPS LOCK on the main keyboard (Figure 2-14).

This key is similar to the SHIFT LOCK key on a typewriter except that CAPS LOCK will only give you capital letters and will not shift anything other than letters. Keys with numbers or symbols are not affected by CAPS LOCK. To get the uppercase of these keys, press the SHIFT key. The SHIFT key will also give you capital letters while CAPS LOCK is off. Press the various alphabetic and numeric keys on the keyboard. Check for the terminal to display the characters as the keys are pressed. Verify that the CAPS LOCK key does what it is supposed to do.

2.4.1.6 OFF-LINE Operating Mode Check

- 1. Type a character. The character will appear on the screen at the cursor location, and the cursor will move one character location to the right.
- 2. With the REPEAT key held down, type another character. The character will appear in all the remaining locations of the top line, and the cursor will be under column 79 (the last column).
- 3. Type a different character. It will replace the last character in the line because that is the cursor location. The cursor advances automatically as characters are typed, until it reaches the last character position in the line. RETURN and LINE FEED must be typed at the end of each line.
- 4. Type the RETURN key. The cursor will move to the left end of the line. Now type LINE FEED. The cursor will move down to the next line. Type a few characters to form the second line.
- 5. Try the rest of the cursor move keys. They will all move the cursor one character position. The BACK SPACE key will move the cursor to the left; the four cursor move keys on the auxiliary keypad will move the cursor one character position in the direction indicated by the arrow.
- 6. Move the cursor to the left-hand margin on a blank line. Alternately type a character and TAB. The typed characters will appear eight character locations apart. These are the TAB STOP locations. If the cursor is at the end of the line, TAB will not move the cursor.
- 7. Position the cursor under a displayed character and type SPACE BAR. The character will be replaced with a space and the cursor will be advanced one character position. The space bar may be used for erasing.
- 8. Type some characters with the SHIFT key and then the CAPS LOCK key held down. Alphabetic characters will appear in uppercase when typed with either SHIFT or CAPS LOCK pressed. Numeric keys are not affected when CAPS LOCK is down. Symbols associated with numeric keys are displayed only when the numeric keys are typed with the SHIFT key held down.

9. Move the cursor to the left-hand margin of the bottom line. With REPEAT held down, type a character key and fill the bottom line.

Type RETURN and LINE FEED. The terminal will move all lines up by one position erasing the bottom line for new entries. The top line is lost in this operation. This is called scrolling and will occur whenever a LINE FEED is typed while the cursor is on the bottom line.

- 2.4.1.7 Escape, Control, and Function Commands Escape and control commands are invoked by:
 - 1. Pressing the ESC (escape) key (Figure 2-14) and then, following with a certain character to identify which escape function is to be performed.
 - 2. Holding down the CTRL (control) key and simultaneously typing a character to identify which control function is to be performed.

Note that the ESC key and the FCN key need only be typed once and then followed by the identifying character (or characters), while the CTRL key must be held down while the identifying character is being typed.

2.4.1.8 Escape, Control, and Function Command Checks

- 1. Audible Alarm Check
 - a. Hold down the CTRL key and simultaneously type the letter G.

Verify that the audible alarm sounds. If the audible alarm does not sound, adjust the VOLUME potentiometer on the bottom of the terminal and repeat the procedure.

- 2. Terminal Self-Test
 - a. Press the CAPS LOCK key.
 - b. Press the ESC key.
 - c. Press the S key. The terminal should execute a self-test.

During the test, the screen will be filled with characters and the audible alarm will sound. Upon completion of the test (approximately 5 seconds), the cursor will appear at home position and the screen will reset.

d. Release the CAPS LOCK key.

CHAPTER 3 OPERATION, PROGRAMMING, AND OPERATOR MAINTENANCE

3.1 CONTROLS AND INDICATORS

.

Two groups of controls are used in the VT62: the operator controls and the keyboard. The operator controls set the operating parameters of the terminal such as intensity, baud rate, etc. The keyboard (and the auxiliary keypad) select the codes to be transmitted to the host computer. The eight LEDs (located to the right of the auxiliary keypad) indicate to the operator when a particular mode or condition is in effect.

3.1.1 Operator Controls

The operator controls and their functions are listed in Table 3-1 and their physical location is shown in Figure 3-1 and Figure 3-2.

3.1.2 Keyboard

Input data to the host computer is entered by typing keys on the main keyboard or the auxiliary keypad. The keyboard transmits uppercase and lowercase alphabetic code, numeric code, firmware-defined code, and user-defined code. Figure 3-3 shows the main keyboard of the VT62.

Fifty-two of the keyboard keys are used to generate any of the ninety-five displayable ASCII characters (040 through 176). The ten remaining keyboard keys are used to implement keyboard operations which are useful in a form-filling application.

3.1.2 Keyboard

Input data to the host computer is entered by typing keys on the main keyboard or the auxiliary keypad. The keyboard transmits uppercase and lowercase alphabetic code, numeric code, firmware-defined code, and user-defined code. Figure 3-3 shows the main keyboard of the VT62.

Fifty-two of the keyboard keys are used to generate any of the ninety-five displayable ASCII characters (040 through 176). The ten remaining keyboard keys are used to implement keyboard operations which are useful in a form-filling application.

3.1.2.1 Alphabetic Keys – All alphabetic keys transmit in uppercase and lowercase code. Uppercase is transmitted when a key is typed while either or both SHIFT keys are down, or while the CAPS LOCK key is down. (The CAPS LOCK key does not affect codes transmitted by keys other than the alphabetic keys. The CAPS LOCK key does have a maintenance function which will be discussed later.) Uppercase and lowercase codes are listed in Table 3-2.

3.1.2.2 Numeric/Symbol Keys – Numeric and symbol key codes are listed in Table 3-3.

3.1.2.3 Function Keys – The ten main keyboard function keys are used to implement keyboard operations in a form-filling application. These keys and their associated functions are listed as follows:

HOME

FORM:

If the form fields are enabled, the HOME FORM key moves the cursor to the first character of the first home field. This is the unshifted mode of the HOME key.

DISPLAY:

If the menu fields are enabled, the HOME DISPLAY key moves the cursor to the first character of the first home field. HOME DISPLAY is the shift mode of the HOME key.

ERASE CHAR

If the current field is left justified and the cursor is not at the beginning of the field, the ERASE CHAR key will cause the cursor to backspace and then erase the character under the cursor. If the cursor is at the beginning of the field, the ERASE CHAR key leaves the cursor there and erases the character under the cursor. If the field is left justified, the text collapses from right to left; if the field is right justified, the text collapses from left to right. The positions left vacant by the justify operation will be filled with the clear character specified in the Field Definition for that field.

NEXT FIELD

If the current field is the last field, the NEXT FIELD key will clear to the end of the current field. If the current field is not the last field, the NEXT FIELD key will clear to the end of the current field and position the cursor to the first character of the next field. A field check will be done no matter what position the cursor is in when the key is pressed.

DELETE FIELD

When selected, the DELETE FIELD key will set the current field to all clear characters and move the cursor to the beginning of the current field.

CLEAR

DISPLAY AREA:

When the CLEAR key is selected, all menu fields are restored to the normal video state. They are deselected and the cursor is positioned to the beginning of the first menu field.

FORM AREA

When the CLEAR key is selected, all form fields are cleared to their clear character values and the cursor is positioned to the beginning of the first form field.

BLANK KEY (PF45)

The BLANK key (PF45) is a user programmable function key. See Appendix A for more information.

DELETE CHAR

When selected, the DELETE CHAR key will delete the character under the cursor. If the field is left justified, the text will collapse from right to left; if the field is right justified, the text will collapse from left to right.

SELECT/DESELECT

This key is only enabled when the terminal is in menu mode and the cursor is in the Display area. Unshifted a menu item is selected. Shifting will deselect a menu item. Selected menu items are displayed in reverse video and deselected menu items are displayed in normal video.

INSERT MODE

Unshifted enables INSERT mode; shifted disables INSERT mode.

In the INSERT mode, if a field is left justified, each character typed into the field is entered under the cursor and all characters at or to the right of the cursor are shifted one position to the right. If the field is right justified, each character typed is entered under the cursor and all characters at or to the left of the cursor are shifted one position to the left of the cursor are shifted one position to the left.

BOUNDARY CONDITION

When a field is filled (no clear characters on the left for right justified field or on the right for left justified field), additional characters typed will not be entered into field and the bell will ring.

ERROR RESET

When an error occurs, a message is printed on the bottom line (if error messages are present), the bell rings, the ERROR LED is lit, and the terminal enters ERROR MODE. Until the operator presses the ERROR RESET key, thereby, acknowledging the error, all keystrokes simply ring the bell. Errors occur if field validation fails, or if the host computer selects an error message to be printed.

3.1.2.4 Auxiliary Keyboard – The 19-key auxiliary keypad (Figure 3-4) is provided for user applications.

The numeric keypad is functionally self-contained. If all replies in the form are numeric, then the entire form can be entered and sent with one hand which need never move from the pad. Most keys on the numeric pad serve two functions. The first function is indicated by the label on the top of the key cap. The second function is indicated by a label on the front of the key cap. This second function is obtained by striking the desired key while the SHIFT key is pressed.

The terminal can be placed in a special mode, selectable by the host software, in which the PRO-GRAM FUNCTION keys operate in single keystrokes, without the use of the SHIFT key. In this case, the program foregoes the normal function of the numeric keypad. These keys and their associated functions are as follows:

Forward Field

If the current field is the last field, move the physical cursor to the last position in field and the logical cursor past field so that no data entry is allowed if a key is pressed. Otherwise, move cursor to the first character position of next field without changing anything in the rest of the current field. Field check will be done no matter what position the cursor is in when the key is pressed.

Backward Field

If the current field is the first field, then move cursor to beginning of current field. If the cursor is at the beginning of the current field then move cursor to beginning of previous field. Otherwise, move cursor to beginning of current field.

Cursor Left

If the cursor is at the leftmost position of a field, then no-operation. Otherwise, move cursor left one position.

Cursor Right

If cursor is at the rightmost position of a field, then no-operation. Otherwise, move cursor right one position. If auto-tab is enabled and pressing this key causes the cursor to be moved to the next field, field checking will be done on the field exited.

Enter

If the keypad is in "numeric" mode then pressing unshifted 0 to 9 or . results in 0 to 9 or .; pressing shifted 0 to 9 or . results in PF0 to PF6 and abort and PF8 to PF10. If the keypad is in "function" mode, then pressing 0 to 9 or . results PF0 to PF6 and abort and PF8 to PF10, independent of the shift key.

3.1.2.5 The REPEAT Key – The REPEAT key (on the main keyboard) is used in conjunction with other keys; it does not transmit a code. Any key that transmits a code to the host will transmit that code repeatedly if pressed while the REPEAT key is down. Keys that transmit more than one code will transmit their sequence repeatedly if pressed while the REPEAT key is down.

The following keys repeat if held down (without the use of the REPEAT key):

VT62 main keyboard – NEXT FIELD, ERASE CHAR, and DELETE CHAR. VT62 auxiliary keyboard – Cursor left and cursor right. Backward Field and Forward Field

All keys for displayable characters can be forced to repeat by the use of the REPEAT key on the main keyboard.

3.1.3 Indicators

The LED display to the right of the keypad is labeled as follows:

The LED labeled	If on when
READY	The DDCMP startup sequence has been successfully received.
KEYBOARD LOCKED	The operator may not type in data or select menu items.
FUNCTION KEYPAD	The keypad is in function (as opposed to numeric) mode.
INSERT MODE	The terminal is in insert mode.
DISPLAY AREA	The cursor is in the display area.
CLEAR TO SEND	A communication line has been established between the termi- nal and the host computer and the terminal can now send data.
CARRIER	A communication line is established between the terminal and the host computer.
KEYING ERROR	The terminal is in error.

The layout of the LED display is shown in Figure 3-4.

3.2 OPERATING PROCEDURE

3.2.1 OFF-LINE

- 1. Make certain that the terminal line cord is not connected to an electrical outlet and that the power (ON/OFF) switch is in the OFF position.
- 2. After making sure that there is room on the platform on which the terminal is located, tip the unit back until it is stable. This must be done to gain access to the switches on the underside of the unit (Figure 3-5).
- 3. Set the ON-LINE/OFF-LINE switch to the OFF-LINE position (Figure 3-6).
- 4. Return the VT62 to its proper operating position.
- 5. Plug the three-prong line cord of the unit into an electrical outlet that meets the requirements of the terminal.

6. Apply power to the terminal by setting the ON/OFF switch to ON. This switch is located on the rear of the terminal.

NOTE

The terminal enters a self-test mode immediately upon power-up. If the terminal CAPS LOCK key is not in the pressed position, the terminal enters Long Self-Test Mode. The VT62 will remain in this mode until the CAPS LOCK key is pressed. When the CAPS LOCK key is pressed, the terminal enters Short Self-Test Mode and executes the Short Self-Test one time (approximately ten seconds). At the end of the Short Self-Test, the terminal exits the self-test mode, the cursor goes to the HOME position (at the top left corner of the display), and the keyboard is enabled.

7. Use the brightness control located on the rear of the terminal to adjust the brightness of the cursor to the desired level. For the most comfortable viewing, set the brightness to the lowest possible level while still maintaining good character definition. High screen intensity causes characters to become fuzzy and prolonged viewing of the bright display is very tiresome.

3.2.2 ON-LINE

CAUTION

Do not attempt to switch the unit ON-LINE now. Damage to the host operating system could result. Please comply with the following procedure.

- 1. Remove power from the terminal by switching the power (ON/OFF) switch to OFF.
- 2. Tip the unit up and set the BAUD RATE switches to the desired frequency. Transmission speed must be set to the same frequency as the host's receiving speed; receiving speed must be set to the same frequency as the host's transmission speed.
- 3. Set the ON-LINE/OFF-LINE switch to the ON-LINE position.
- 4. Set the ON/OFF switch to ON to restore power to the terminal. When the Short Self-Test has terminated, the terminal can communicate with the host.

3.3 USER PROGRAMMING

Appendix A explains the concepts necessary to understand the workings of the VT62, and describes in detail the effects of all the commands to which the terminal responds.

3.4 USER MAINTENANCE

The keyboard circuits contain the only moving parts of the terminal and require no preventive maintenance by the owner. The terminal may be cleaned with soap and water or any mild detergent. Although the terminal's shell provides superior resistance to damage from solvents, cleaners with solvents should not be used.

The unit packaging is not meant to be weatherproof: there are several openings in the case through which liquids, coins, paper clips, and other objects can fall. Such objects will disturb the electronic operation of the terminal if they come in contact with the circuitry. For this reason, avoid putting drinks and metal objects on the top of the terminal or using excessive water to clean the terminal. The keyboard is an area where the electronics are particularly close to the exterior. Rubbing the keys with a dry or barely moist cloth should suffice to clean them. Do not remove the keycaps to clean them more thoroughly; damage may result in the switch contacts if they are replaced incorrectly.

3.4.1 Irregularities in the Appearance of the Screen

At some time in its life, the picture tube may appear to darken at each character position. This is a normal phenomenon; it does not affect the life expectancy of the tube and will not interfere with the display of characters when the unit is in operation. It is caused by the fact that the terminal lights up the screen only at the character positions, breaking in the phosphor at those positions on the screen.

Not all units contain the same type of picture tube. For this reason, the color of the screen may not be the same from unit to unit.

If, for these or other reasons, the appearance of the screen is not satisfactory, colored filters may be attached to the screen. A special nib was designed at the base of the screen in order to hold such filters in place.

3.5 DEC MAINTENANCE ARRANGEMENTS

There are four ways that an owner can arrange for service on a VT62.

- 1. Depot Maintenance Service will be done at the DEC depot. You buy a mailer, pack the VT62 in it, and return it to the depot. Upon completion of service, DIGITAL returns the unit.
- 2. On-Site Contract This is the traditional priority service contract, available with various coverage hours.
- 3. On-Site, Per-Call Service In this arrangement, DIGITAL charges for time and materials actually used.
- 4. On-Site User Maintenance Module-swapping kits are available. Failed modules are returned to the DEC depot for repair in the mailers in which the swapping kits are mailed.

In some geographical areas, additional options are available; contact your local DIGITAL Field Service Office for information.

APPENDIX A VT62 FUNCTIONAL SPECIFICATION

A.1 GENERAL

The VT62 is a video terminal with major characteristics as follows:

Block Mode DDCMP Protocol Polled Slave Station Multi-drop Full or Half-duplex Switchable: Synchronous up to 4800 baud Asynchronous up to 9600 baud Dial-up or Leased Forms Filling Functionality

The VT62 is a terminal designed specifically to be a part of a form-filling or other transaction processing system. The host computer defines the areas on the screen which the operator is allowed to enter, to fill in, or to select. The terminal provides most of the real-time detailed checking of operator responses, but the ability to extend some of the more complicated checking, such as file searches, to the host computer is provided. Operator errors are signaled by an audible tone, an error light, and a short, but descriptive, message of what went wrong. Since the host computer loads the message array, it is not necessary to restrict the messages to the English language.

The visible cursor is associated only with keyboard activity. Text sent by the host must be preceded by either the screen position where it begins, or a code which indicates that it is to be sent directly to the printer. Host activity, printer activity, and keyboard activity proceed simultaneously.

The VT62 communicates in block mode as specified by the DDCMP protocol, either asynchronously or synchronously, in full or half-duplex, utilizing the common datasets over either dial-up or leased lines.

The VT62 will operate as a DDCMP slave station and will operate only in a polled environment, regardless of whether the connection is multi-point or point-to-point.

All exchanges of information between the host and the terminal are completely controlled by the host. The terminal cannot, under any circumstances, send information of any kind to the host that was not requested and allowed by the host.

A.2 SCREEN FORMAT

The display screen consists of 24 lines, with 80 character positions on each line.

The display screen may logically be divided into three areas: the Display/Menu Area, the Form Area, and the Error Line.

Lines 1 to 24 of the screen may be defined to be all Display/Menu Area, or all Form Area, or part Display/Menu Area and part Form Area and part Error Line. If both are defined, the Display/Menu Area and the Form Area are adjacent and separated on a whole line boundary, and the Display/Menu Area must be above the Form Area. The screen format is defined by means of the RESET AND DEFINE SCREEN command (Section A.9.11.1).

If error messages are defined, then line 24 will be used as the Error Line. The terminal displays an error message by first clearing line 24, and then printing the appropriate message there. Thus, it is a logical error to attempt to use line 24 as both part of the Display/Menu Area or Form Area and as the Error Line. If no error messages have been defined since the terminal has been powered up or since a GENERAL RESET command has been executed (which clears all error messages), line 24 is not cleared when an error occurs and can be used as part of the Display/Menu Area or Form Area.

A.3 CURSOR

There is one visible cursor. When the terminal is in menu mode the cursor may be positioned in any menu field in the Display/Menu Area. When the terminal is in form mode, the cursor may be positioned within any form field in the Form Area. (The terminal can be in menu mode and form mode simultaneously).

The cursor is only used by the terminal operator to select menu fields or to indicate where data is to be entered within a form field.

The cursor is not used by the host to write text. Each command which the host issues to the terminal contains sufficient information to direct the terminal microprocessor to the position of the data in the screen buffer where data is to be entered.

A.4 MENU DEFINITIONS

A menu is a sequence of menu fields. A menu field is a defined sub-area of the Display Area. A menu field definition consists of a row, column, count, and video attributes specification. A menu field may begin at any character position in the Display Area and extends from left to right. If the count for a menu field does not expire at the end (column 80) of a line, the field continues at the beginning (column 1) of the next line.

The operator moves the cursor from one menu field to another by means of the Forward Field or Next Field or Backward Field keys. The cursor may move within menu field by means of the Cursor Right and Cursor Left keys.

The host issues a set of menu definitions to the terminal by means of the <CLEAR MENU DEFINI-TIONS AND DEFINE MENU FIELDS> command. The terminal stores menu definitions received from the host and uses these definitions to identify which field (if any) the terminal operator selects when the menu select key is typed.

A maximum of 128 total menu fields and form fields may be defined with no restriction as to the number of each so long as the total of 128 is not exceeded.

A.5 FORM DEFINITIONS

A form field is a defined sub-area of the Form Area. A form field definition consists of a row, column, count, video attribute, and field attribute specification. A form field may begin at any position in the Form Area and extends from left to right. If the count for a form field does not expire at the end (column 80) of a line, the field continues at the beginning (column 1) of the next line.

The operator moves the cursor from one field to another by means of the Forward Field or Next Field or Backward Field keys. The cursor may move within a form field by means of the Cursor Right and Cursor Left keys.

The host issues a set of form definitions to the terminal by means of the <RESET FORM DEFINI-TIONS AND DEFINE FORM FIELDS> command. The terminal stores the form definitions and uses them to control cursor positioning in the Form Area and to check the data entered into each field against the field attributes (e.g., aphabetic, numeric) for that field.

A maximum of 128 total form and menu fields may be defined with no restriction on the number of each so long as the total of 128 is not exceeded.

A.5.1 Form Field Attributes

The following attributes may be defined for each field:

- C1: Alphabetic (A-Z or a-z or Blank)
- C2: Alphanumeric (A–Z or a–z or Blank or 0–9)
- C3: Numeric (0–9)
- C4: Signed Numeric (0-9, or., or, or -, or +)
- C5: Any Displayable (ASCII 040–176)
- C6: Field must not be empty (i.e., not all clear characters)
- C7: Field must be full or empty
- C8: Auto-transmit
- C9: Auto-tab
- C10: Clear Character: The character to which a form field is initialized by a <CLEAR> Command; the character used to fill in places in a form field when some operator key entry is made which causes characters to be deleted in that form field
- C11: Right Justified
- C12: Protected Field: Field may not be modified from the keyboard.

C to C5 are mutually exclusive (only one may be set).

C1 to C5 is checked as each character is entered.

C6 to C9 are checked when field is exited in the forward direction.

C10 takes effect when field is cleared.

C11 right justified.

C12 is checked when the field is entered; if the field cannot be modified from the keyboard, then the cursor is moved on to the next field in the same direction (forward or backward).

If a data character is keyed into a field and is not an allowed character as defined by the Form Field Attribute, the terminal will always enter Error Mode (the bell will ring, the keying error light will be on, and the keyboard will be locked). If an error message has been defined by the <DEFINE ERROR MESSAGE> command, line 24 will be cleared and that message will be displayed. If an error message has not been defined, line 24 will not be cleared or altered.

A.6 DISPLAY AREA USAGE

The Display Area, if defined, may be used in one of two modes: menu mode and non-menu mode.

A.6.1 Menu Mode

Menu mode is enabled if: there are one or more menu fields defined; and there are one or more function keys which are defined by a <REQUEST INPUT> command to send menu fields.

The purpose of menu mode is to allow the terminal operator to select, in general, multiple items from a menu, and then to transmit these choices to the host by pressing a function key that has been appropriately defined.

The cursor (by means of the <Home Display> key) may be placed in the Display Area only when the terminal is in menu mode. Once in the Display Area, the cursor may be moved among the menu fields in the Display Area. The terminal operator, upon positioning the cursor over any character position in a menu field, may record the choice of that field by pressing the <Select> key. In order to let the terminal operator see what choice has been made, the menu field will be displayed in reverse video when selected. If the cursor is in a position which is defined to be part of more than one menu field, only one menu field will be selected and that menu field will be displayed in reverse video mode. The <Deselect> key deselects the current menu item and causes it to be displayed in normal video. <Deselect> is the shifted position of the <Select> key.

The terminal operator may make as many menu selections as allowed by the menu attributes (Section F.6.1.1). When an appropriately defined function key is typed, those menu field numbers (and possibly content) which are selected will be transmitted to the host, providing that an input request is pending.

A <REQUEST INPUT> command can specify that either menu field numbers only, or menu field numbers together with the content are to be transmitted to the host. For single menus, the "numbers only" transmission would be sufficient. However, if the host wishes to sequentially transmit identically formatted menus, the host can identify a particular operator choice by the menu content being transmitted along with the field number. The terminal operator would control the reception of successive menus by pressing an appropriately defined function key when a new menu is desired.

A.6.1.1 Menu Attributes – A menu may have one or both of the following two attributes:

- 1. no more than one menu item may be selected
- 2. no less than one menu item may be selected.

A.6.2 Non-Menu Mode

If menu mode is not enabled the terminal defaults to non-menu mode. Non-menu mode is used to dynamically write text to the Display Area.

The host can clear, write text to, and scroll the Display/Menu area by means of the commands listed in Section A.9.8.2.1.

By using these commands and appropriately defined function key responses, an interaction can be set up with the operator such that the operator can control the flow of text to the display area and could, for example, call for text on a line by line basis by using one function key or perhaps call for the host to send a new set of text by using another function key.

A.7 FORM AREA USAGE

A.7.1 Form Mode

Form mode is enabled if: there are one or more form fields defined, and there are one or more function keys defined by a <REQUEST INPUT> command to send form fields.

The purpose of form mode is to allow the terminal operator to make keyboard data entries into the form fields, to have the terminal validate the data entered using the attributes for each field, and then to transmit the validated data to the host when the operator types an appropriately defined function key. When the terminal is in form mode, the cursor may be positioned within any form field. Inter field cursor movement is accomplished by using the <next field> <forward field>, and <backward field> keys. Intra field cursor positioning is accomplished by means of the <cursor left> and <cursor right> keys.

A.7.2 Packed and Unpacked Transmissions

The terminal can transmit data in either packed or unpacked form. In packed form the terminal transmits only those fields which have modified state set and does not send trailing clear characters. In unpacked form, the terminal transmits every character in every field. The host can dynamically select packed or unpacked transmissions. Packed transmissions use the communications lines most efficiently, and unpacked transmissions use host CPU time most efficiently.

A field is set to a modified state by:

- 1. Simulating forms activity if so specified.
- 2. Typing a character (including a character which has been defined as the clear character) which is entered into the field.
- 3. Pressing the <delete character> key if the operation of the key can be accepted into the field and regardless of whether the content of the field was actually changed.
- 4. Pressing the <erase character> key if the operation of the key can be accepted into the field and regardless of whether the content of the field was actually changed.
- 5. Pressing the <delete field> key if the field did not already contain all clear characters when the key was pressed.
- 6. Pressing the <next field> key if the remainder of the field did not contain all clear characters.
- 7. Pressing the <clear> key if the field did not contain all clear characters at the time the key is pressed.

A field is cleared from a modified state by:

- 1. A <REQUEST INPUT> command if so specified in the command.
- 2. The following commands:

<RESET FORM DEFINITIONS AND DEFINE FORM FIELDS> <CLEAR FORM FIELDS> <CLEAR THEN WRITE FORM FIELDS> <WRITE ALL FORM FIELDS> The modified/unmodified state of a field is not altered by:

- 1. Exiting a field by pressing the <back field>, <forward field>, <home display>, <home menu>, <cursor left>, or <cursor right> keys.
- 2. Exiting a field by pressing the <next field> key if the remainder of the characters in the field are already clear characters.
- 3. Deleting a field by pressing the <delete field> key if the field is all clear characters when the key is pressed.

A.7.3 Auto-Transmit Mode

A form field may be defined to be auto-transmit. An auto-transmit field is one which is transmitted to the host as soon as the terminal operator leaves the field in a forward direction. Prior to the autotransmission, field validation is performed on the field according to any attributes specified for that field.

All form fields which have the auto-transmit attribute set will take effect as auto-transmit fields when the terminal is placed in auto-transmit mode. The terminal is placed in auto-transmit mode by executing a <REQUEST INPUT> command with <AUTO-TRANSMIT MODE> enabled. When autotransmit mode is not enabled, auto-transmit attributes for individual fields are not in effect.

Auto-transmit is used primarily when the host wishes to extend the field validation accomplished by the terminal.

A.8 COMBINED DISPLAY/FORM AREA USAGE

A <REQUEST INPUT> command can be issued with both the <MENU MODE> and the <FORM MODE> set. The terminal operator will then be able to make menu selections in the Display Area and enter data into the Form Area before typing an appropriately defined function key. The cursor can be freely moved back and forth between the Display Area and the Form Area by means of the <HOME FORM/HOME DISP> key. When an appropriately defined function key is finally typed, responses will be generated for the menu selections and/or the forms field data entered according to the definition for the function key typed.

A.9 HOST/TERMINAL/HOST MESSAGES

All exchanges of information between the host and the terminal are completely controlled by the host. The terminal cannot, under any circumstances, send information of any kind to the host that was not requested and allowed by the host.

All information from the host to the terminal is in the form of Command Packets.

All information from the terminal to the host is in the form of Response Packets.

A.9.1 Command

A command consists of a command code, count and data sequence. The terminal upon receiving all the bytes in a command will validate the command and then execute the command.

A command is in no way related to a DDCMP block. It is possible that a single command would require several DDCMP blocks or that several commands could be transmitted in a single DDCMP block.

If a command requires more than one DDCMP block, there are no restrictions on the size of each block other than that they must be no greater than the maximum block size accepted by the VT62. (Refer to the definition of a Response Packet. The Response Packet Header contains information regarding the size of the terminal's command buffer.)

The format of a command is as follows:

COMMAND CODE:

8-bit binary encoded command identifier. Range: 1-255; is an illegal COMMAND CODE.

COUNT:

A 7-bit or 14-bit binary encoded count of the length (in bytes) of the following data field. If the high-order bit of the first 8-bit byte of the count is set, then that first byte of the count is followed by a second 7-bit binary encoded character which is the most significant 7 bits of a 14-bit, binary encoded count.

NOTE

A count byte is REQUIRED with ALL commands. A command byte=0 is legal for some commands. Refer to specific command formats.

REMARK

Counts which are in the range from 128 to 255 require a 14-bit representation.

DATA:

Any character in the range 0 to 255.

A.9.2 Command Packet

A Command Packet is a complete message which the host transmits to the terminal. A Command Packet consists of at least a Command Packet Header and may also have one or more commands. A complete packet may require more than one DDCMP block. There are no restrictions on how the Command Packet may be partitioned into DDCMP blocks other than that they must be no greater than the maximum block size accepted by the VT62. After the terminal has received a complete command packet, it validates and executes each command in the sequence before proceeding to the next command.

If an invalid command is encountered, the terminal aborts execution of the command packet and indicates an unsuccessful completion by setting the packet completion bit in the Response Packet Header. All of the commands in the command packet before the invalid command are executed correctly and all of the commands after the invalid command are ignored. If another Command Packet has been loaded after the Command Packet with an invalid command, the terminal will process it by validating and executing commands in a normal fashion. A response packet will be send to the host even if not requested after an invalid command is encountered.

When all of the commands in a packet are received validly and executed, the Response Packet Header will have the Command Error (CE) bit set to 0 indicating successful packet completion. Note that with successful packet completion, the Response Packet will not be sent unless requested.

A Command Packet is limited in size to that specified for the VT62. If a Command Packet larger than this size is sent, the VT62 will then issue a DDCMP START to the host in response to any poll with the select bit set indicating that the terminal is in an undefined state and that the host must issue a DDCMP START for the terminal to become functional again.

The terminal can have only one Command Packet in the process of being validated or executed at any point in time. Other Command Packets can be completely or partially loaded in the terminal if there is available Command Packet buffer space but will not be acted upon in any way until the current packet has been completely validated and all execution begun or been aborted by a command error. Refer to potential errors described under Input Commands. In particular, note that the commands which initiate input requests do not execute for the duration of the request; their execution is completed immediately and further commands (and Command Packets) may be processed while the operator is typing and before or while the data requested is being sent to the host. Also refer to the section on DDCMP protocol activity if DDCMP blocks cannot be received due to full Command Packet buffer.

A.9.3 Response

A response characterizes the data (e.g., menu data, form data, function key data) which the terminal transmits to the host. A response consists of a response code, count and data sequence.

There is no limit to the size of a Response. The size of a Response does not affect the space available in the Command Packet buffer. (Internal remark – the terminal does not process commands while it is creating responses.)

The format of a response is as follows:

DATA:

A.9.4 Response Packet

A Response Packet is a complete message which the terminal transmits to the host only if the host has initiated activity from the terminal. A Response Packet consists of at least a Response Packet Header and may also contain one or more Responses. A Response Packet is used to group together, for transmission to the host, all responses which are generated by the terminal.

All requests for status (Send Status or Send Command Packet Buffer Size) and any requests for nondata responses (Send Terminal ID or Send Terminal Type or Send Self-Test Results) will be sent after the terminal finishes processing the Command Packet in which the requests occur.

At the present time in the VT62, all requests for status and other non-data responses will be sent in a separate Response Packet from other input.

A.12 COMMUNICATIONS PROTOCOLS

A.12.1 Logical Communications Protocol

The VT62 will be a tributary DDCMP station and operate only in a polled environment, regardless of whether the connection is multipoint or point-to-point.

It is the host computer's responsibility to know the "address" of the VT62. The VT62 will only accept DDCMP blocks of up to 2048 characters in length. Blocks greater than 2048 characters will cause the terminal to respond with a <NAK-Message Too Long>. The terminal will send DDCMP blocks of no greater than 256 bytes of data (maximum DDCMP block would be 8 bytes of header, 256 bytes of data, and 2 CRC characters).

After the terminal is powered up or after it has run self test or if an overlength command packet has been received or if a <RESET> is issued, the terminal will respond to all polls that are not a START with a START to the host. The host must issue a DDCMP START for the terminal to respond to Command Packets.

A DDCMP START issued to the VT62 will cause a complete reset of the VT62 with the exception of the stored SELF TEST RESULTS.

The terminal will always respond with a STACK message to a START message from the host. The terminal always verifies the CRC before acting on data it has received.

If the VT62 command buffer is temporarily too full to accept the full DDCMP block, the terminal will respond with a <NAK-Buffer Temporarily Unavailable> until space is available in the buffer for that block.

A.12.2 Physical Communications Protocols

A.12.2.1 Asynchronous

The VT62 operates up to 9600 baud asynchronous. Support is provided for 103 data sets (or equivalent) on dial-up or leased lines, full duplex. Support is also provided for 202 datasets (or equivalent) on dial-up half duplex or leased full duplex or half duplex lines.

A.12.2.2 Synchronous

The VT62 operates up to 4800 baud synchronous. Support is provided for 201 or 208 datasets (or equivalent) on dial-up half duplex lines or leased full duplex or half duplex lines.

APPENDIX B INSTALLATION PROCEDURES FOR COMMUNICATIONS OPTIONS

B.1 REMOVING THE COMMUNICATIONS OPTION

To remove the communications option, refer to Figures B-1 through B-4, unit assembly drawing 0-UA-VT62-0-0, and perform the following steps.

- 1. Place the unit upside down on a bench or table (Figure B-1).
- 2. Remove the cable clamp securing the option cable to the base assembly (two Phillips head screws, $8-32 \times 0.56$) using a Phillips screwdriver.
- 3. Remove the base front screen (three hex-head screws, $8-32 \times 0.38$) using a 6.35 mm (1/4 inch) nut driver.
- 4. Remove the switch panel board connector P1 from J4 on the I/O board (Figure B-2).

CAUTION

Make certain that P1 is replaced correctly on J4, with the black wire of the cable toward the front of the unit. P1 incorrectly replaced on J4, will damage the I/O board upon power-up, necessitating its replacement.

5. Remove the communications option card from its socket on the I/O board. The option card plugs into one (Figure B-3) or both (Figure B-4) of the two 11-pin sockets located near the center of the I/O board. The card is secured by arrowhead snap-on fasteners. Squeeze the fastener and lift the card from its socket.

B.2 INSTALLING THE COMMUNICATIONS OPTION

To install the communications option, refer to unit assembly drawing 0-UA-VT62-0-0 and perform the following steps.

- 1. Remove the communications option card presently installed (Paragraph B.1).
- 2. Install the new card by plugging the row of straight pins on the card into the proper socket on the I/O board as shown in the applicable figure for the communications option (which follows) and secure the card. Figure B-3 shows the installation of the 20 mA communications option card. Figure B-4 shows the installation of the EIA communications option card (with control), BN61B.
- 3. Route the card cable approximately as shown in the applicable figure for each type of card so that the cable will exit the unit through the notch in the cable clamp provided for it.
- 4. Reassemble the unit by reversing steps 1 through 5 of Paragraph B.1.
